Owii Giizhiikigaade Dibamaadiwin digosin banaajitaasowin dibagewin gewe E' miigsejig Agaa Zhaabwiiig Maamowi Yaang Waajii'ejig zhisin onji \$10,000 apiinish \$200,000 dibaamijigaadeg agaa piitaag maanaaiidoodamowin agaa wiisgikaagwaad miinwaa age Ondiziwin Zhoonyaa \$200,000,000 (CDN) awii aasgaabwitamowaad makwenjigewin nankiwin, mina-yaawin miinwaa mina zhayaa nawinnkiwin, miinwaa iniwewin miinwaa inaadiziwin maajiiish'kaachigewinan.
